Storm's Story

While enjoying a Sunday morning walk, my walking partner and I saw a sick looking kitten in the alley behind Haywood's Restaurant in Muncy. My husband and I went back with the car about an hour later and couldn't find him. The next day, while out walking - about four blocks from his original location - I found him sitting on the front porch steps of our friend's home. After giving a short chase, we were able to snag him. His eyes and nose were running and full of nasty-looking gunk...so we called our vet and asked them to have a look. He was diagnosed with a severe upper respiratory infection; since we had two other cats in the house, we had to put him in "quarantine"...so we built a temporary pen in our garage.

Patti Barclay came to our rescue and helped me with his twice daily doses of antibiotics and eye medications. We had to be very careful and diligent with hand and clothes washing so we did not infect our other cats. Storm's pen had a window screen affixed to it so he was able to enjoy the outdoors from inside his pen. He watched the birds, the gardener and even got to see a house being demolished on a neighboring lot. The Pepper Street walkers met him and greeted him as they walked down the street so he became quite popular.

While conquering his respiratory infection we had him tested for feline leukemia and the initial test results came back positive. A more extensive test was given and that, too, was positive. This meant he could not live in a home with other cats. While we had intended to bring him into our home, other developments had occurred since he "found" me. Two other kittens had been thrown from a car window about a mile away from our home and after a day, we were able to trap them and bring them home. When tested, they were negative so they came into the house and began acclimating. Now we knew Storm had to be placed elsewhere, so the search began! The folks at Twin Hills Veterinary Hospital and Patti were wonderful...offering support and direction as we pursued compassionate owners for this beautiful survivor with the odds against him. Patti and all the others who helped us nurse him to health were captivated by Storm's charm and affection and his personality continued to blossom.

Finally, a cat-loving couple (Richard & June) stepped forward and, over Thanksgiving, Storm went off to Connecticut to his new home. He has a new veterinary office relationship established and they have also been very responsive to Storm's special needs. With care and attention, Storm can have a normal cat life. And, like here, he has charmed his new owners and all that he meets.

June writes: "After the initial "spraying" of the entire household with a subsequent visit to the vet's for antibiotics, and then back to the vet's for his neutering, and then more antibiotics and eye medicine (I suppose as a result of the anesthesia), he is now victorious and the household pretty much runs to his wishes!

He has become the stairwell terror and has his own 100 foot ball of twine that is unraveled daily/wrapped around everything he can find and then re-wound by Richard so he can do it again tomorrow; has a 30 foot leash so he can explore much more of the outdoors; enjoys a "fake" outdoor area built on our closed-in porch so he can wander among June's plants when the weather is inclement; loves the sound of Richard's hammer, power drill and staple gun; even has June describing him as the "perfect kitten, handsome, warm, adorable".

The "downside" is he is so demanding that Richard must hold him for his mid-morning and afternoon naps so Richard's productivity is way down. Storm also gets up at 6 am and screams for breakfast and his twine romp! And then there's the "can't go away" thing where Richard uses Storm and "his condition" as an excuse to stay homebound. Storm, of course, is medicine-free right now, so go figure!"





ORGANIZATIONS THAT HELP PAY FOR VET CARE

Most of us are by no means rich. If you find yourself in a dire financial situation and your cat (or other pet) needs care, there are some organizations that help pay for veterinary bills or give you credit cards specifically for veterinary bills:

American Animal Hospital Association www.aahahelpingpets.org

The heartbreak happens all too often – a pet owner is unable to afford treatment and their sick or injured companion animal pays the price. If the owner is elderly, disabled or on a fixed income, the cost of care may be too much of a stretch for their pocketbook. Perhaps they have been victimized by crime, property loss or a job layoff and are experiencing a temporary financial hardship – making it too difficult to afford pet care. And some animals, brought to clinics by Good Samaritans, don't have an owner to pay for treatment. Whatever the situation, the fact remains the same: When sick or injured animals are unable to receive veterinary care, they suffer. Through the AAHA Helping Pets Fund, veterinary care is possible for sick or injured pets even if they have been abandoned or if their owner is experiencing financial hardship.

Angels4Animals, a non-profit organization and a program of Inner Voice Community Services, has a mission to serve as the guardian angel of animals whose caretakers find themselves in difficult financial situations. At Angels4Animals we believe that animal owners should not have to say goodbye to the animals that they love. Our work is accomplished in conjunction with veterinary clinics across the country, eager to assist as many animals, and their owners, as possible. Our services range from financial aid to complete treatment to those pets and pet owners in need.

Anyone can apply for funds, but SAF offers assistance primarily to those on fixed incomes or with annual incomes below \$35,000. Exceptions are made depending on circumstances. It is always a one-time grant.

The Pet Fund www.thepetfund.com

The Pet Fund is a registered 501(c)3 non-profit association that provides financial assistance to owners of domestic animals who need urgent veterinary care. Often animals are put down or suffer needlessly because their owners cannot afford expensive surgery or emergency vet visits. Companion animal owners must often make the difficult decision to put an animal down or neglect urgent medical needs because of the costs involved. The purpose of the Pet Fund is to work towards a future where decisions about companion animal medical care need never be made on the basis of cost.

2008 RESIDENT STATISTICS

Last year was an awesome year for both LAPS and its residents. Our intake and adoption success rates were phenomenal. This was due to our increase in media coverage as well as the arrival of Petco at the Lycoming Crossings Shopping Center near the Lycoming Mall. Petco allows LAPS to take cats/kittens to the store where they are available for adoption.

- 86 cats/kittens were accepted into LAPS.
- 91 cats/kittens were adopted, 19 of these were adopted at Petco.
- 10 cats/kittens were returned, 5 of these have since been adopted again.
- 5 cats crossed The Rainbow Bridge.

Our current shelter population is 85 cats/kittens with 10 of those cats/kittens in foster care due to various reasons. LAPS is always looking for foster homes for our special needs cats. If you are interested in fostering a special needs cat, please contact the shelter.
